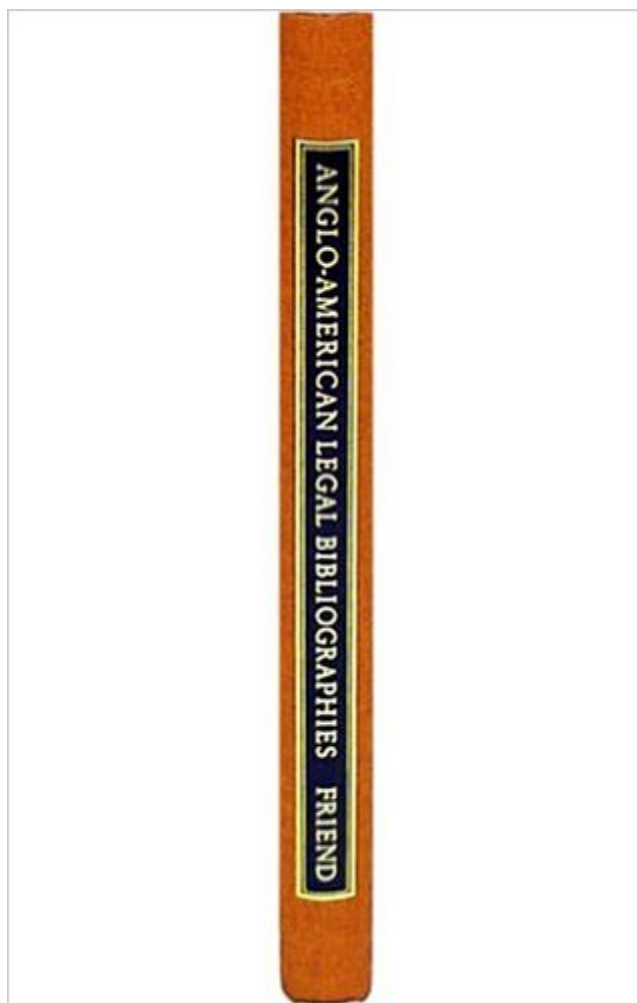

Friend introduces his study with a lengthy historical survey of the important developments in legal bibliography.
